**SUPPLEMENTAL TAX LEVY ORDINANCE FOR THE VILLAGE OF MACKINAW IN  
TAZEWELL COUNTY, ILLINOIS**

**SECTION 1:**

Ordinance 820 is amended in the following manner:

1. The levy for the line item "Salaries-President, Trustees, and Employees" within the General Fund is hereby changed from \$7,050.00 to \$20,374.13.
2. The total General Fund levy as shown in Section 1, Page 2, is hereby increased from \$72,789.00 to \$86,113.13.
3. The total amount levied contained in Section 1 on Page 10 is hereby changed from \$230,014.00 to \$243,338.13.

**SECTION 2:**

Except as modified and changed by this Supplemental Tax Levy Ordinance, the Tax Levy adopted on December 13, 2010, shall remain in full force and effect.

**SECTION 3:**

The purpose of this additional levy is to correct errors in an earlier certificate filed with the County which did not accurately reflect the actions of the Board.

**SECTION 4:**

If any section, subdivision or sentence of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

**SECTION 5:**

A certified copy of this Supplemental Tax Levy Ordinance shall be filed with the County Clerk of Tazewell County, Illinois, as soon as may be practical following adoption of this


**SECTION 6:**

This Ordinance shall take effect immediately.
