MAY 1, 2016 THROUGH APRIL 20, 2017

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE
OF MACKINAW, TAZEWELL COUNTY, ILLINOIS:

SECTION 1:

Ordinance No. 917, which was AN ORDINANCE MAKING BUDGETS AND APPROPRIATIONS FOR THE CORPORATE PURPOSES OF THE VILLAGE OF MACKINAW, ILLINOIS FOR THE FISCAL YEAR OF MAY 1, 2016 THROUGH APRIL 30, 2017 is hereby amended by interlineation in the following manner:

1. On page 4, the total appropriation for the community center/food pantry is corrected by deleting the number "77,500.00" and substituting in place thereof "\$277,500.00".
2. On page 14, the total amount appropriated herein is corrected by deleting the number "\$4,482,415.00" and substituting in place thereof the number "\$4,682,415.00".

SECTION 2: Except as modified by this Ordinance, Ordinance No. 917 of the Village of Mackinaw shall remain in full force and effect.


SECTION 3: If any section, subdivision or sentence of this ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 4: A certified copy of this Supplemental Budget and Appropriation Ordinance shall be filed with the County Clerk of Tazewell County by the Village Clerk within 30 days after the adoption of this Ordinance.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage and approval according to law.
