

ORDINANCE NO 964

AN ORDINANCE AUTHORIZING A PORTION OF HOMER STREET TO BE ANNEXED TO THE VILLAGE OF MACKINAW

WHEREAS, the plat for Miller's First Addition to the Town, now Village of Mackinaw was recorded in the Recorder of Deeds Office of Tazewell County in Plat Book D at Page 22; and

WHEREAS, in the plat of Miller's First Addition to the Town, now Village of Mackinaw a street known as Homer Street was dedicated along the East boundary of the platted subdivision; and

WHEREAS, in Ordinance No. 594 recorded in the Recorder of Deeds office of Tazewell County, as Document No. 0005236, the Village of Mackinaw vacated all of the streets and alleys in Miller's First Addition to the Town, now Village of Mackinaw, including but not limited to Homer Street; and

WHEREAS, when the Village of Mackinaw vacated Homer Street that portion of Homer Street that is south of the north half of lot 1 in Miller's First Addition was conveyed by the vacation to the Village of Mackinaw; and

WHEREAS, questions have previously arisen concerning whether Miller's First Addition to the original Town, now Village of Mackinaw was annexed to the Town of Mackinaw by reason of the fact that the original annexation records, which were filed with the Towns of Mackinaw at the time of the platting of Miller's First Addition, were either lost or misplaced by the original Town, now Village of Mackinaw; and

WHEREAS, the Trustees of the Village of Mackinaw have determined that the property to be annexed fulfills the statutory requirements of the Illinois Municipal Code, 65 ILCS 5/7-1-9 regarding the annexation of property that is owned by the annexing municipality. The foregoing described property is uninhabited, unincorporated and contiguous to the Village of Mackinaw; and

WHEREAS, the Board of Trustees of the Village of Mackinaw, pursuant to 65 Illinois Compiled Statutes 5/7-1-9 are annexing the property described in SECTION TWO by ordinance; and

WHEREAS, a public hearing was held on June 8, 2018 by the Village of Mackinaw Planning Commission and Zoning Board of Appeals. A report of findings has been submitted to the Trustees of the Village of Mackinaw. Said report of findings recommends that the property that is the subject of this ordinance be zoned agricultural since that is the current zoning classification for the Mackinaw water plant that is the adjoining property owned by the Village of Mackinaw; and

WHEREAS, no hearing is required to be held by the Board of Trustees pursuant to 65 ILCS 5/7-1-9 because the property that is the subject of this ordinance is owned by the Village of Mackinaw; and

WHEREAS, the Village of Mackinaw has determined that the proposed annexation is in the best interest of the Village of Mackinaw

NOW, THEREFORE, be it ordained by the Trustees of the Village of Mackinaw as follows:

SECTION ONE: The Trustees of the Village of Mackinaw find as facts the recitals hereinabove set forth.

SECTION TWO: Pursuant to 65 ILCS 5/7-1-9, the following described property is hereby annexed into the Village of Mackinaw:

That portion of Homer Street that is south of the north half of Lot 1 in Miller's First Addition to the original Town, now Village of Mackinaw

PIN: A part of 13-13-17-208-001


SECTION THREE: The Village Clerk is hereby directed to record a certified copy of this ordinance.

SECTION FOUR: An accurate map of the annexed territory is attached to this ordinance.

SECTION FIVE: This ordinance shall be in full force and effect from and after its passage, and approval and in the manner provided by law.
