

ORDINANCE NO. 1058

AN ORDINANCE AMENDING THE VILLAGE OF MACKINAW MUNICIPAL CODE TO PROVIDE AMENDMENTS RELATING TO TEMPORARY CLOSURE OF TRUCK ROUTES

WHEREAS, the Village of Mackinaw has designated certain streets within the corporate limits as Truck Routes, by ordinance codified as Schedule II of Chapter 77 of the Mackinaw Municipal Code; and

WHEREAS, the Village of Mackinaw pursuant to 65 ILCS 5/11-80-2 has the power to regulate the use of streets, which includes the ability to close streets temporarily;

WHEREAS, 625 ILCS 5/15-316(c) provides authority for the Village of Mackinaw with respect to roads under its jurisdiction to prohibit the operation of trucks or other commercial vehicles, or may

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MACKINAW:

SECTION 1: Schedule II of Chapter 77 of the Village Code of the Village of Mackinaw is hereby amended in the method and manner shown below, with additions shown in underlined font and deletions in strikethrough font:

Chapter 77: Traffic Schedules

Schedule II Truck Routes

- A. Trucks of up to 20,000 pounds per single axle and 34,000 pounds per tandem axle may be driven on the following streets of the village, which are hereby designated as truck routes.

Street	Location
Fast Street	From the intersection of Orchard Street to the West side of Main Street
North Main Street	From the intersection of Fast Street to the village limits
Orchard Street	From the intersection of Orchard Street with Illinois Route 9 to the north side of Fast Street

B. Exceptions

1. None

C. Temporary Closure. The Truck Route designated herein may be temporarily

closed by a resolution adopted by the Corporate Authorities of the Village of Mackinaw, for purposes including, but not limited to, construction or maintenance of the roadway, or for public safety purposes. In the event of a temporary closure of the Truck Route designated herein, signage approved by the Street Superintendent shall be posted providing notice of the temporary closure of the Truck Route.

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect immediately upon passage and approval as provided by law.


SECTION 4: Ordinance No. 513 of the Village of Mackinaw, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 513 shall remain in force and effect except as modified by this Ordinance.
