### VI. ALLOWING LIQUOR AT MACKINAW COMMUNITY CENTER EVENTS:

Liquor Commissioner Friend spoke with the board regarding being approached to allow liquor during rental events at the Mackinaw Community Center. Committee Member Ellis feels that by allowing liquor during rental events at the Mackinaw Community Center it would bring more use from the building. Committee Member Laidig also felt that by allowing liquor it would increase the revenue of the building. Attorney Pat McGrath spoke with the board regarding the legalities of allowing liquor at the Mackinaw Community Center since this was a Village leased/owned property and that changes to the Mackinaw Municipal Code would be necessary. Committee Member Ellis moved that the Liquor Control Commission make the recommendation to the Village Board to allow Attorney Pat McGrath to make the necessary changes to the Village of Mackinaw Municipal Code to (1) exempt the Community Center from the public intoxication and open container prohibition, and (2) to create a caterer's classification of liquor license with an abbreviated application process for holders of a valid state and local license issued by another municipality. Seconded by Committee Member Laidig.

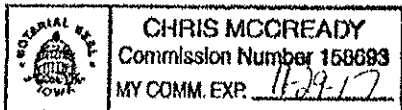
